Workman hath & by these presents doth Agree bargain sell and Convey unto
the said Andrew Leake his heirs or assigns A Lot or Tract of Land Situate
Lying and being in New-Gloucester so called, in the County of Moutland
Province aforesaid: Together with the Dwelling house thereon and all Appurten
ances & Improvements Belonging to the said Lot & premises for the Just and
full sum of one hundred & thirty pounds Money of the Province at 6/ 11/ 0
to be paid to the said William Workman or his heirs at or before the first day
of October in the Year of our Lord 1764 and further the said William Workman
doth Covenant promise & agree for himself and his heirs Executors or Admin^{ors}
to Deliver Peaceable and Quiet Possession of the said Lot of Land & house aforesaid
on the first day of May Next ensuing the date hereof and also give & convey
A good and Sufficient deed or Warranted for the Land and premises aforesaid:
Now for the True performances of all and every of the aforesaid Covenants
Both parties bind themselves unto each other In the Just and full sum
of Two hundred & Sixty pounds Money as aforesaid: In Witness whereof
